## Access

All Forcepoint MSSP Partner training can be found in the Forcepoint Cyber Institute (FCI). Within FCI is a variety of training courses and certifications, including: eLearnings, instructor-led, virtual instructor-led, blended learnings, digital learning assets, and more.

To access FCI, first make sure you have access to the [Partner Portal](#). If you do not have access, please reach out to [Partner@forcepoint.com](mailto:Partner@forcepoint.com), or contact your CAM. Once onboarded, you will receive an email to set your credentials.

Once in the Partner Portal, click on the 'Training and Compliance' tab and then 'Forcepoint Cyber Institute'. This will take you to the [Learner Dashboard](#) page which is a personalized dashboard where you can view assigned courses assigned, in-progress or completed training, and any certifications earned.

To access available training, click 'Learning Content' and 'Content Catalog' to see the complete Forcepoint catalog.
